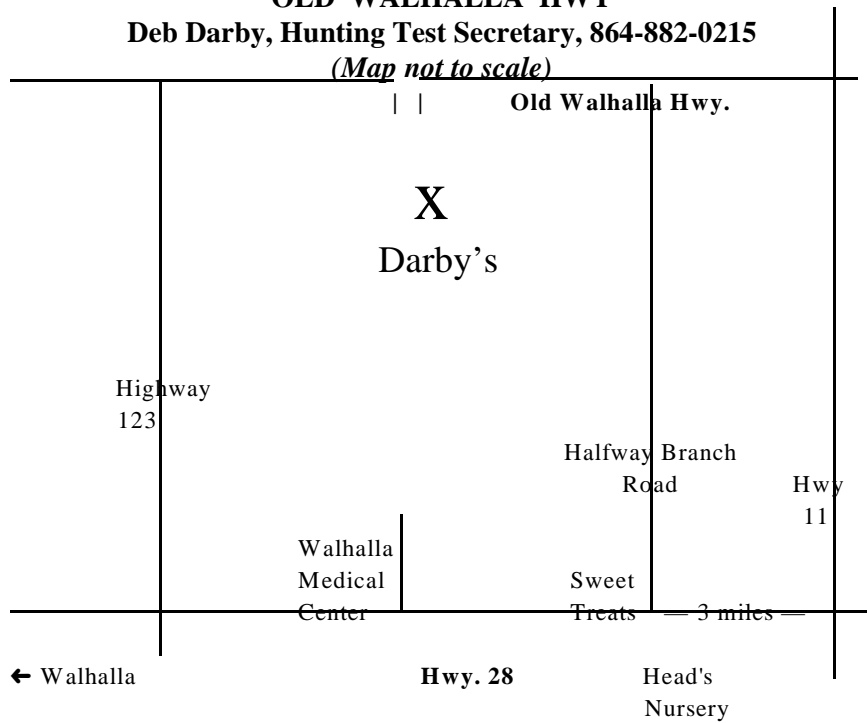

**FROM ATLANTA:** Take I-85 North to SC line. Exit on Exit #1, Hwy 11 North. Go 20 miles to Junction of Hwy 28. Turn right on Hwy 28 and go past Walhalla Medical Center on left. Turn left on to Halfway Branch Road. Go one-half mile, turn left on to Old Walhalla Hwy. Go approx, three-tenths of a mile. Grounds on left.

**FROM CHARLOTTE:** Take I-85 South to Hwy. 153 to Easley. Take Hwy 123 to Easley, Clemson, Seneca, then right on Hwy 28 in Seneca. Go approx. 3 miles toward Walhalla. Turn right on to Halfway Branch Road.

Go one-half mile, turn left on to Old Walhalla Hwy. Go approx. three-tenths of a mile. Grounds on left.

**FROM COLUMBIA:** Take I-26 to I-385 to Greenville, then south on I-85. Proceed as from Charlotte.
